### Introduction

Regional Studies Center at the University of Mosul was established on August 24, 1985 under the name Turkish Studies Center. Its scope expanded in the early 1990s to include, in addition to research on relations with Iraq's northern neighbor Turkey, the newly independent Islamic republics of Central Asia that emerged from the former Soviet Union. On September 17, 2003, it was renamed Regional Studies Center, and its focus broadened to cover neighboring countries of Iraq as well as selected Middle Eastern states.

The Center is a research institution concerned with producing strategic studies on Iraq, its neighbors, and several Middle Eastern countries, aiming to develop relations with them in political, economic, social, and cultural fields. The Center consists of a council that includes the Director of the Center, department heads, and specialized faculty members. Its academic departments are:

**It was established under University Order No. 5/5/7806 dated 7 April 2014.**

The department aims to prepare research, studies, and books related to public policy, and to support decision-makers with specialized studies addressing public issues that concern both society and policymakers. These efforts provide ideas and perspectives aimed at offering solutions through specialized public policy research.

The department also seeks to strengthen engagement with public institutions relevant to its field, provide consultation on political affairs and public policy for decision-makers, and enhance the role of universities and research centers in serving the state and society. #### **Functions of the Center's Council**

1. Approving the Center's general policy in scientific and administrative fields and following up on its implementation.
2. Approving the Center's annual scientific plan and monitoring its execution in accordance with the Center's specialization and the instructions of the Ministry of Higher Education and Scientific Research, and submitting recommendations to the University Presidency for approval.
3. Proposing research and studies that serve society, utilizing the results of studies, transferring them to practical application, and following up on their implementation.
4. Proposing instructions aimed at developing the Center.
5. Discussing progress in implementing the work plan and taking appropriate measures.



6. Approving the processing of promotion files for researchers from the teaching staff working at the Center, in accordance with promotion regulations issued by the Ministry of Higher Education and Scientific Research.
7. Recommending the establishment of scientific relations with relevant institutions inside and outside Iraq, according to regulations and after obtaining the University Presidency's approval.
8. Recommending the establishment, cancellation, or merging of scientific formations and administrative divisions and preparing their annual staffing in line with the development of the Center's work, after obtaining the University Presidency's approval.
9. Contracting and scientific cooperation with other institutions and individuals inside Iraq to diagnose and study specific scientific or societal problems and find solutions, according to regulations and after obtaining the University Presidency's approval.
10. The Council has the right to delegate some of its powers to the Director of the Center.

### **Scientific Functions of the Center**

- a. Developing scientific plans, programs, studies, and specialized research in accordance with the Center's scope and the general research policies approved by the Ministry of Higher Education and Scientific Research.
- b. Conducting theoretical, applied, and field studies and research required by development plans, working to advance them, submitting related proposals, utilizing research outcomes, and providing researchers with needed resources.
- c. Providing databases within the Center's specialization through a library that contains books, periodicals, and references.
- d. Publishing scientific research and disseminating it to relevant institutions and cooperating with them in applying its findings.





- e. Issuing publications, periodicals, books, and scientific bulletins.
- f. Contributing to deepening scientific awareness by delivering lectures and organizing conferences, seminars, academic meetings, workshops, and training courses at the national, Arab, and international levels.
- g. Exchanging expertise with scholars and researchers inside and outside Iraq in line with the Center's plans and scientific objectives.
- h. Establishing and expanding scientific cooperation with national, Arab, and international academic institutions relevant to the Center's goals and specialization.

### **Functions of the Center Director**

- a. Managing the scientific, financial, and administrative affairs of the Center.
- b. Representing the Center or appointing a representative to act on its behalf in activities required by the Center's work inside and outside Iraq.
- c. Implementing decisions of the Center's Council.
- d. Recommending the selection of staff members.
- e. Approving the publication of completed research.
- f. Preparing the Center's annual budget, staffing plan, and final accounts.
- g. Granting incentive rewards to staff according to authorized powers.
- h. Approving the participation of staff in various activities inside Iraq.
- i. Nominating staff for postgraduate studies inside and outside Iraq.
- j. Proposing the establishment, merging, or cancellation of Center formations.
- k. Recommending approval of study leave requests.



1. Approving the purchase of the Center's scientific and administrative needs, including books and journals, according to regulations.

#### **Authority of the Center Director**

1. Supervising work performance within the Center and monitoring staff activities.
2. Assigning tasks among employees to ensure smooth workflow.
3. Approving annual leave not exceeding two weeks and confirming medical leave.
4. Recommending approval of annual and medical leave exceeding two weeks.
5. Recommending disciplinary action against underperforming staff.
6. Proposing letters of appreciation and recognition for outstanding staff.
7. Recommending salary increases and promotions to higher grades.
8. Recommending the transfer or secondment of Center staff according to applicable regulations.
9. Representing the Center in scientific and technical conferences and seminars relevant to its specialization.
10. Distributing responsibilities among staff in ways that enhance work performance and development.
11. Recommending staff delegation inside and outside Iraq.
12. Recommending various allowances for all Center staff.
13. Evaluating staff performance and submitting it to the University Presidency.
14. Receiving, sending, and signing the Center's official correspondence.
15. Recommending delegating the Director's duties to the Deputy during periods of leave or official travel.

#### **Functions of Academic Staff at the Center**



According to Article (19) of the Scientific Research Centers Regulation No. (1) of 1995 and Instruction No. (148) of 2002, academic staff at the Center shall perform the following tasks:

1. Conducting assigned research and scientific studies—individually or as part of a team—according to departmental and Center Council research plans.
2. Teaching and supervising undergraduate and postgraduate students and participating in thesis/dissertation defense committees.
3. Providing scientific consultations to relevant government sectors through established cooperation mechanisms between ministries, universities, and non-ministerial institutions.
4. Participating in conferences, seminars, and academic activities inside and outside the university.
5. Contributing to the development of administrative and technical staff through continuing education programs.
6. Authoring and translating academic books, publishing research and studies within their scientific specialization, and utilizing their outcomes in support of development goals.
7. Disseminating scientific and research activities through various media to enhance scientific and cultural awareness.
8. Carrying out scientific and administrative duties relevant to the Center's work.
9. Fulfilling tasks assigned by the Center Director.
10. Organizing and holding workshops, seminars, and conferences within the Center's specialization.
11. Conducting scientific visits and participating in research teams within their academic specialization.

### **Work Procedures for Academic Staff at the Center**

First: The workload (in working hours) of a research academic staff member in the research center shall be equivalent to the workload of a faculty member of the same academic rank or administrative position.

Second: A special form shall be prepared for each research project, including the importance of the research and the time required to complete it. Based on this, the weekly research hours allocated for each study are determined, provided that they are not less than six (6) hours and do not exceed twelve (12) hours per week, in special cases approved by the Center's Board of Directors.

Third: The academic researcher in the center shall submit no fewer than three (3) and no more than four (4) research studies annually, depending on their significance. The researcher shall receive compensation for additional hours exceeding the assigned workload, equivalent to the compensation for extra teaching hours in the college and according to the academic rank, provided that the additional hours do not exceed forty (40) hours per week.

### **Scientific Affairs Division**

The Scientific Affairs Division is part of the administrative organizational structure of Regional Studies Center. It was established pursuant to University Order No. 9/8/16661 on 5/12/2017. The division is responsible for following up and documenting all scientific affairs of the Center's academic staff, including research accomplishments, conferences, symposiums, workshops, and cultural and scientific seminars.

### **Duties of the Scientific Affairs Division:**

1. Follow-up and documentation of the scientific activities of academic staff inside and outside the center.
2. Preparing the annual statistical reports related to the activities of academic staff in the scientific departments.
3. Preparing quarterly reports on the activities of scientific departments every three months.
4. Following up and documenting completed, published, and planned research outputs.



5. Preparing minutes of the Scientific Committee meetings in the center.
6. Preparing academic promotion forms for academic staff.
7. Preparing forms for discussion seminars.
8. Preparing research accomplishment forms.
9. Coordinating the preparation of academic activities (seminars, workshops, symposiums, and conferences) in cooperation with the scientific departments.
10. Maintaining communication with the Scientific Affairs Department at the University Presidency and providing them with planned and completed activities.
11. Coordinating with the Scholarships and Cultural Relations Department at the University Presidency.
12. Coordinating with the Quality Assurance and University Performance Department at the University Presidency.

## **Units of the Scientific Affairs Division**

### **\* Studies and Planning Unit**

Tasks: Communicating with the Studies and Planning Department at the University Presidency, responding to their official correspondence, preparing statistics related to completed and published studies and research, implementing scientific activities requested by the department, and following up on activities related to sustainable development.

### **\* Media and Government Communication Unit**

Tasks: Providing the University's Media and Government Communication Department with the center's scientific activities, publishing the center's activities on its website and social media pages, and managing all media-related tasks for the center.

### **\*University Quality Assurance and Performance Unit**



Tasks: Communicating with the University Quality Assurance and Performance Department at the University Presidency regarding the annual evaluation of center staff; preparing the annual evaluation form and ensuring its timely completion; entering the annual evaluation data for faculty and staff into the University Performance Evaluation System; and monitoring the implementation of institutional accreditation standards at the center.

#### **\*Scientific Output Marketing Unit**

Tasks: Monitoring and documenting research that serves the job market and submitting it to the Scientific Affairs Department using a specific form for use by relevant entities and institutions; and uploading published scientific research to the Applied Research Platform of the Scientific Affairs Department at the University Presidency.

#### **\*Women's Affairs Unit**

Tasks: Overseeing scientific activities related to women's affairs and issues, and coordinating its activities with the Women's Affairs Unit at the University Presidency.

#### **\*Human Rights Unit**

Tasks: Overseeing scientific activities related to human rights, and coordinating its activities with the Human Rights Division at the University Presidency.

#### **\* Library Unit**

Tasks: Documenting, classifying, and registering books and publications to facilitate access for researchers; providing library services to researchers, faculty members, and undergraduate and graduate students; assisting and guiding researchers in obtaining resources for their research or studies.

#### **Administrative Affairs Division**

The Administrative Affairs Division is part of Regional Studies Center's administrative organizational structure. It was established by University Order No. 9/8/16661 dated December 5, 2017, and undertakes the following tasks:



- ❖ Monitoring the administrative affairs of the Center's staff.
- ❖ Organizing the Center's administrative affairs.
- ❖ Monitoring employee attendance and tracking departure times.
- ❖ Monitoring the Center's incoming and outgoing mail.
- ❖ Registering, documenting, and archiving books received by and issued from the Center.
- ❖ Monitoring promotions and allowances for Center staff based on merit.
- ❖ Preparing human resources statistics for the Center's staff.

### **The Administrative Affairs Division Consists of:**

#### **\* Director's Office Unit**

Tasks: Implementing the Director's directives by printing official correspondence and sending it to the University Presidency, disseminating the Director's directives to faculty and staff, receiving incoming official correspondence from the University Presidency, registering and documenting outgoing official correspondence to the University Presidency, its colleges, and research centers, distributing it according to its respective files, electronically archiving it, and maintaining official and personal employee files.

#### **\* Personnel and Human Resources Unit**

Tasks: Monitoring promotions and annual bonuses for Center staff, preparing and continuously updating the relevant lists, preparing, processing, and registering annual and sick leave requests, preparing human resources and personnel statistics, and updating the Center's human resources system data.

#### **\* Accounts Unit**

Tasks: Managing the financial affairs of Center staff, including preparing and monitoring employee payrolls, as well as monitoring the disbursement of promotions, annual bonuses, rewards, travel allowances, and all other matters related to the Center's finances.

#### **\* Warehouse Unit**

Tasks: Registering the center's furniture and entering it into the warehouse, keeping purchase and warehouse entry slips in special records and discarding old ones, conducting the annual inventory of the center's furniture, as well as preparing forms related to the center's needs for furniture, equipment and office supplies, and following up on furniture request forms at the university presidency until they are completed and finalized.

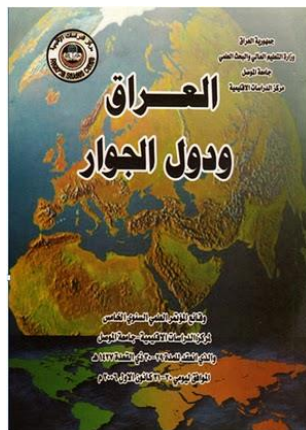
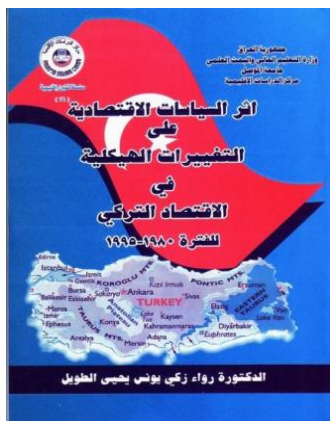
### Center publications

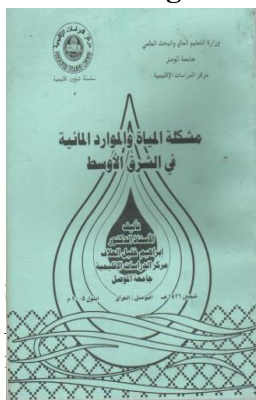

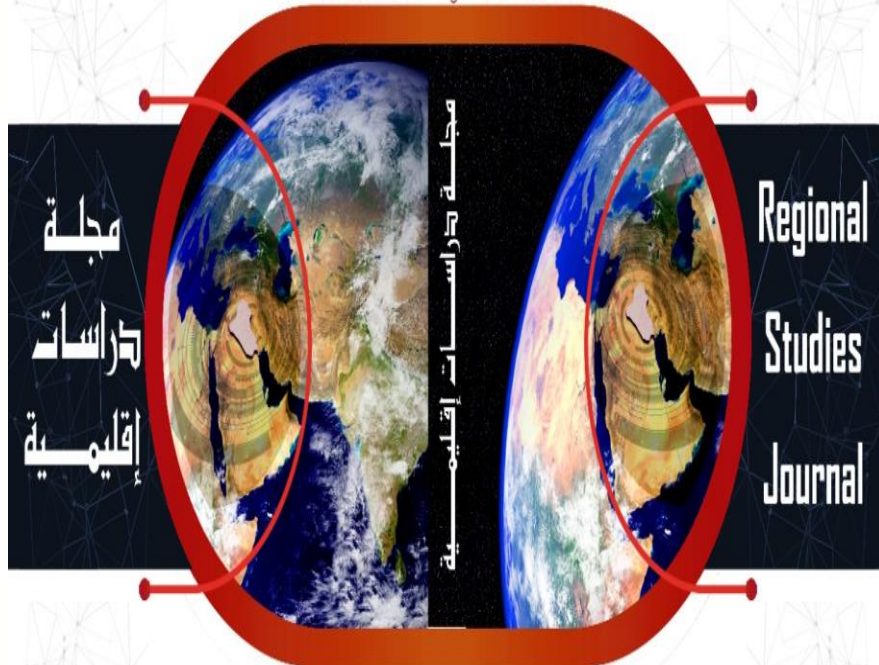

### **Third: Scientific Research**

The center's faculty members conduct scientific research within the center's areas of specialization. The center's administration develops an annual research plan for proposed projects to be completed by researchers during the academic year. The center produces more than fifty scientific papers annually in its areas of specialization: political, economic, historical, legal, social, and international relations fields. Research is also included in the conference and seminar program, both within and outside the center. The center's strategic research focuses on Iraq and examines its relations with neighboring countries, both near and far. Its interest in neighboring countries such as Iran, Turkey, and the Arab states stems from the central point that events and developments in each of these countries affect, in one way or another, the others.

### **Fourth: Scientific Workshops**

The center organizes and holds scientific workshops throughout the academic year. These workshops cover topics that fall within the center's interests and the field of sustainable development. During these workshops, the center hosts some professors and researchers from outside the center to participate in these workshops.

### **Fifth: Discussion Panels**

The center holds discussion panels weekly throughout the academic year. These panels cover topics that fall within the center's interests and the field of sustainable development. During these panels, the center hosts some professors and researchers from outside the center to participate in these discussion panels.

### **Fifth: Other Activities**

In addition to the above activities, professors and researchers at the Center participate in conferences and seminars held at the University of Mosul and other Iraqi universities, as well as those held





outside Iraq. Professors at the Center also contribute by delivering lectures at the University of Mosul and other Iraqi universities, in addition to supervising postgraduate students and examining master's and doctoral theses and dissertations at the University of Mosul and elsewhere.

#### **Sixth: The Center's Future Focus**

The Center aspires to expand its focus to include the study of all phenomena and challenges facing Iraq and its regional and international environment. This includes conducting studies on contemporary Islamic trends in Iraq and neighboring countries, modern economic trends, globalization and its positive and negative effects, and the issue of interfaith and intercultural dialogue, as well as political, economic, social, and cultural problems.
