# THE INTRODUCTION

**The Industrial Advisory Council of the College of Law, University of Mosul, was formed pursuant to Administrative Order No. 9/13/4567 dated June 11, 2025. It is an organizational advisory body, often established within an academic framework, with the aim of fostering cooperation between the College of Law and the industrial sector (including judicial, legal, and legal institutions, as well as legal and consulting firms). The term "industrial" is used here in its broad sense, encompassing the legal professional labor market, not just "industry" in its .production sense**

**The primary objectives of the Faculty of Law's Industrial Advisory Council are: -**

## **Aligning academic outcomes with labor market needs**

The Council aims to bridge the gap between academic education and practical application by providing recommendations for updating curricula and programs to keep pace with .developments in the profession

## **Linking the Faculty of Law to professional aspects**

Helps create partnerships between the Faculty and law firms, ministries, judicial bodies, and .legal firms to provide training and employment opportunities for students and graduates

## **Continuous evaluation of academic programs**

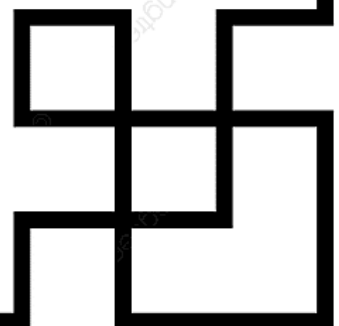
The Council participates in reviewing and approving curricula to keep pace with current .legislation and trends in law, both locally and internationally.

.relationships

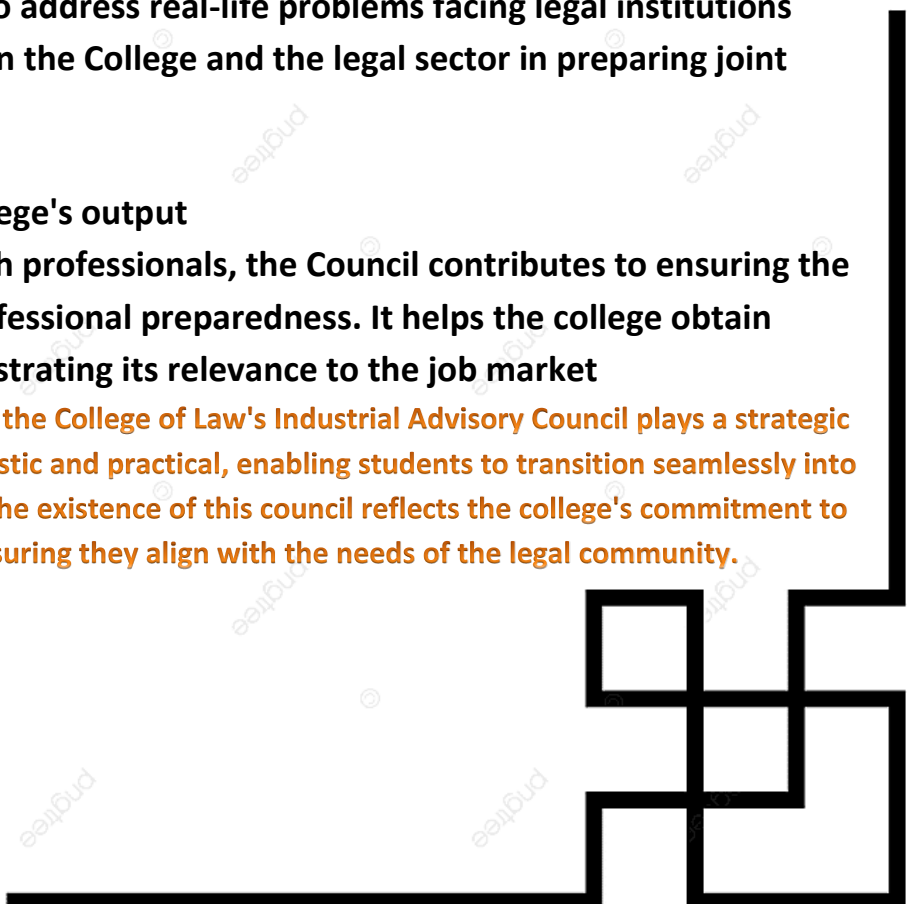
## **4. Supporting applied scientific research .**
